Interventions/Ideas

- Drug/alcohol targeted @late high school
- Make access to recovery easy to find
- Create a pathway to recovery flow chart
 - You are here – map with
 - Self-screening tool – can call X, option A, option B, etc., (help you need that works for you)
- Treatment that includes healthy body, nutrition, related to weight
- Focus interdiction – school, law enforcement on high school, drugs, marijuana and alcohol users switch to meth.
- Sober activities targeted at late teens (connect to a positive group/mentors – church, etc.)

Referrals to adult prevention services include supportive housing as part of re-entry from hospital, prison, etc.
